

HOW YOUR LEGACY WILL BE USED

Funds received from Legacy Society members are not used to pay the costs of operating our parish.

They are accumulated and only used for special capital purchases and capital replacements.

FORMS OF BEQUESTS

Because a charitable bequest to your parish is usually only a part of an estate plan it can take various forms.

The two most common bequests are a specific dollar amount or a percent of the total estate after taxes and administrative expenses.

The commitment can also be accomplished outside of the will by making the parish the beneficiary of an individual retirement account (IRA), life insurance policy, certificate of deposit or trust.

CHANGING YOUR WILL OR LIVING TRUST

It is not necessary to have your present will or living trust changed in order to make a bequest to your parish. It can be accomplished by attaching a codicil to the will or an amendment form to the living trust.
